

MILLER MOTORSPORTS PARK BARBASOL/MUSTANG CHALLENGE Contest
OFFICIAL CONTEST RULES

1. How to Enter the Contest:

(a) The contest will begin at 12:01 a.m. Mountain Daylight Time on May 1, 2008. The contest ends at 12:00 p.m. midnight Mountain Daylight Time on August 15, 2008. The Sponsor of the contest is Miller Motorsports Park, Utah, L.L.C. and Barbasol, c/o 2901 North Sheep Lane, Tooele, UT 84074.

(b) To participate in the contest, participants must log onto mustangchallenge.com/Barbasol, and fill out and submit the official entry form. Entry may also be made at Miller Motorsports Park at each race held there by completing an entry form and dropping the form in the designated entry box. No mechanically reproduced entries will be accepted.

(c) One entry per person.

(d) Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled, delayed or deleted computer or network transmissions, inability to access any Web site or online service, or any other error or malfunction, or late, lost, illegible, mutilated, incomplete, incorrect, inaccurate, misaddressed or misdirected entries, or theft or destruction or unauthorized access to or alterations of entry materials, whether caused by the participant or by any of the equipment or programming utilized in this contest. If, for any reason, the internet portion of the contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the contest, and to disqualify any participant who tampers with the operation of the contest or website or violates these Official Rules of the contest. If the contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at www.mustangchallenge.com, and the winner will be selected from among all eligible entries received prior to the termination date. Caution: Any attempt by a participant to deliberately

damage any website or undermine the legitimate operation of the contest is a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such participant to the fullest extent of the law.

(e) In the event of a dispute regarding the identity of an electronic participant, electronic entries will be deemed submitted by the authorized account holder of the email submitted, as of the time of the entry.

(f) Odds of winning depend on number of eligible entries received.

2. Eligibility Restrictions:

(a) The contest is open to residents of United States, ages 18 and older. Employees of Miller Motorsports Park, the Larry H. Miller Group of Companies, Barbasol, the Ford Racing Mustang Challenge, and of their respective affiliates, parents, subsidiaries and advertising agencies, and the directors, managers, employees and agents of such entities, and the immediate family members of all such persons (spouses, siblings, parents and children), are ineligible to participate or win.

(b) All entries become the sole property of Sponsor and will not be returned. By entering, each participant agrees to abide by these Official Rules and all decisions of Sponsor. No correspondence will be acknowledged. Entries may be used for advertising and/or trade purposes without compensation unless prohibited by law.

3. Prize:

(a) There will be one (1) grand prize awarded. The grand prize winner will be awarded a trip for two (2) persons to Miller Motorsports Park to see the Ford Racing Mustang Challenge Series Finale race on September 21, 2008 (including airfare, 2 nights hotel accommodations, transportation to and from the hotel and Miller Motorsports Park and tickets to the race). The grand prize winner will also get to waive the green flag at the start of the race.

(b) The grand prize winner will be selected on or about September 1, 2008 by a random drawing from among all eligible entries received during the contest period.

Approximate prize value: \$ 5,000

(c) Sponsor reserves the right to validate all claims made in entries. The winner must allow Miller Motorsports Park staff, producers / crew to visit the winner's home to validate claims and tape interviews for television broadcast and other media purposes.

(d) The winner will be notified by email (which will be sent to the email address submitted in the winner's entry information) or by telephone, within forty-eight (48) hours after being selected. The Winner's name will appear on the millermotorsportspark.com website. IF SPONSOR IS UNABLE TO CONTACT A WINNER BASED ON THE INFORMATION CONTAINED ON THE ENTRY FORM WITHIN FORTY-EIGHT (48) HOURS OF THE SELECTION, AN ALTERNATIVE WINNER WILL BE SELECTED BY THE JUDGES BY RANDOM DRAWING FROM AMONG ALL ELIGIBLE ENTRIES RECEIVED. THE WINNER MUST SIGN A WINNER'S AFFIDAVIT OF ELIGIBILITY AND RELEASE WITHIN THREE (3) DAYS OF NOTIFICATION, OR THE PRIZE WILL BE FORFEITED AND AN ALTERNATIVE WINNER CHOSEN BY THE JUDGES.

(e) Each participant agrees to follow these Official Rules and hold harmless and indemnify Miller Motorsports Park, Barbasol, the Ford Racing Mustang Challenge, and each of their respective parents, subsidiaries, affiliates, directors, officers, employees and agents against any and all liability, damages or causes of action (however named or described), with respect to or arising out of the participant's participation in the contest.

(f) Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash. Sponsor reserves the right to substitute a prize of comparable value at Sponsor's discretion.

(g) Decisions of Sponsor with respect to the contest are final.

(h) No more than the advertised number of prizes will be awarded.

4. Conditions:

(a) Payment of all federal, state and local taxes are the sole responsibility of the winner and the winner may receive an IRS Form 1099 or equivalent from Sponsor. All federal, state and local laws apply.

(b) All expenses on receipt and use of a prize are the sole responsibility of the winner. The grand prize winner, by accepting the prize, (i) agrees to release, waive, discharge, hold harmless and indemnify Miller Motorsports Park, Barbasol, the Ford Racing Mustang Challenge, and each of their respective parents, affiliates and subsidiaries, and their respective advertising, promotion and production agencies, and each of their respective officers, directors, employees and agents from and against any and all liability, damages, claims or actions of any kind whatsoever, whenever the same may accrue, for injuries, damages or losses to persons (including death) and property which may be sustained in connection with the receipt, ownership or use of the prize or while preparing for, participating in, and/or traveling to any prize-related activity, whether such claims or actions are on behalf of the winner or the winner's heirs, representatives, administrators or assigns; and (ii) grants to Miller Motorsports Park, Barbasol, the Ford Racing Mustang Challenge, and each of their respective parents, subsidiaries and affiliates the right to use the winner's name, voice, picture and/or likeness for purposes of advertising, broadcasting, trade purposes and publicity in any and all media now known or hereafter invented, without further permission, notice or additional compensation (except where prohibited by law).
